Item 2 – Educational Background and Business Experience

In 2024 he joined The Leaders Group, Inc. as a Registered Representative and TLG Advisors, Inc. as an Investment Advisor Representative.

Item 3 - Disciplinary Information

Registered investment advisers are required to disclose all relevant facts about any legal or disciplinary issues that you need to know about before deciding to invest your money with them. He has a Judgment from 2011 for unpaid credit card debt related to a past business venture. He has an outstanding tax lien from 2021 related to his 2016 taxes. He was discharged from LPL Financial for facilitating a real estate transaction with customer without notice to and approval from Firm.

Item 4 - Other Business Activities

Mr. Kim sells commission-based products (such as insurance or annuities) as a registered representative of The Leaders Group, Inc., a FINRA-registered broker-dealer. He also sells other fixed insurance products. He owns real estate land and properties that he rents out and develops for renovation and rental income or sale for capital gains.
