# Item 2 – Educational Background and Business Experience

# **Item 3 - Disciplinary Information**

Registered investment advisers are required to disclose all relevant facts about any legal or disciplinary issues that you need to know about before deciding to invest your money with them. Ms. Powell has a customer complaint in 1992. Customer purchased PaineWebber Gas Ltd Ptnship on secondary market at a discounted price. Soon Paine Webber repriced the product much lower, and the client filed a compliant. PW settled for \$15k without telling the advisor and had Ms. Powell sign an agreement to it a year later.

### **Item 4 - Other Business Activities**

Ms. Powell sells commission-based products (such as insurance or annuities) as a registered representative of The Leaders Group, Inc., a FINRA-registered broker-dealer. She is a Financial Planner at Orion Financial Associates. She also may sell other fixed insurance products and manages personal rental properties.

#### **Item 5 - Additional Compensation**

Ms. Powell provides investment-planning advice to her customers on a fee basis. If you were to purchase a commission-based product from her, she will explain how she is paid and how it differs from a feebased transaction. In addition, she may receive compensation from the activities detailed in Item 4 above.

## **Item 6 - Supervision**

- Compare activity in your account with your investment objectives;
- Ensure that your financial information and investment objectives have been recorded;
- Confirm that you are contacted annually to find out if there are any changes in your financial information or investment objectives;
- Verify that you receive quarterly statements;
- Make sure your advisory fees are being charged correctly;
- Ensure that we comply with your wishes concerning directed brokerage arrangements;
- Check to see if you are invested in securities that don't match your risk tolerance.
