#### **Item 4 - Other Business Activities**

Mr. Morris sells commission-based products (such as insurance or annuities) as a registered representative of Simplicity Investments, Inc., a FINRA-registered broker-dealer. He's also an agent at Valley View Advisors selling fixed insurance products. He also does business coaching and consulting.

#### **Item 5 - Additional Compensation**

Mr. Morris provides investment-planning advice to his customers on a fee basis. If you were to purchase a commission-based product from him, he will explain how he is paid and how it differs from a fee-based transaction. In addition, he may receive compensation from the activities detailed in Item 4 above.

#### **Item 6 - Supervision**

- Verify that you receive quarterly statements;

- Ensure that we comply with your wishes concerning directed brokerage arrangements;
- Check to see if you are invested in securities that don't match your risk tolerance.
