Item 2 – Educational Background and Business Experience

Item 3 - Disciplinary Information

Registered investment advisers are required to disclose all relevant facts about any legal or disciplinary issues that you need to know about before deciding to invest your money with them. Ms. Johnson has no such issues on her record.

Item 4 - Other Business Activities

Ms. Johnson sells commission-based products (such as insurance or annuities) as a registered representative of Simplicity Investments, a FINRA-registered broker-dealer. She may also sell other fixed insurance products as an Independent Insurance Agent. She also offers Estate Planning/Trust Advisor services and is also a Residential Property Manager.

Item 5 - Additional Compensation

Ms. Johnson provides investment-planning advice to her customers on a fee basis. If you were to purchase a commission-based product from her, she will explain how she is paid and how it differs from a fee-based transaction. In addition, she may receive compensation from the activities detailed in Item 4 above.

Item 6 - Supervision

We supervise our investment advisor representatives in the following ways:

- Compare activity in your account with your investment objectives;
- Ensure that your financial information and investment objectives have been recorded;
- Confirm that you are contacted annually to find out if there are any changes in your financial information or investment objectives;
- Verify that you receive quarterly statements;
- Make sure your advisory fees are being charged correctly;
- Ensure that we comply with your wishes concerning directed brokerage arrangements;
- Check to see if you are invested in securities that don't match your risk tolerance.
